You are entitled to be registered to Sheguiandah First Nation and alive on September 9, 2023

Entitled babies born between September 9, 2023 up to and including January 18, 2024

All entitled Sheguiandah First Nation Registrations initiated on or before June 10, 2024

To assist you and to ensure you are properly recording your information on to the Robinson Huron Treaty Settlement Release and Discharge Agreement, please follow the instructions below.

PAGE 1 - APPLICANT MEMBER INFOMRATION

Your <u>full name</u> as it appears on your Certificate of Indian Status (Status Card), Birth Certificate, or Driver's License must be provided.

Address: Must include street number, street name, apartment number or unit number, post office box number (if applicable), city, province, state, country and postal code.

Primary Phone Number: You must provide a phone number with area code in case SFN Administration needs to contact you regarding personal information provided

Alternate Phone Number: Please provide an alternate phone number in the case that SFN Administration cannot reach you through your primary phone number. (*Optional*)

Email: Please ensure you are recording your email address accurately. Please provide an alternate email address/back-up email address in the case that SFN Administration cannot reach you through your primary email address.

Birth Date: Ensure you record your birth date in legible form. Either write your birthday in full or record as month/day/year.

Certificate of Indian Status # (10 digits). Please include the full number. All Sheguiandah First Nation Members' Certificate of Indian Status numbers begin with 176. ALL 10 digits MUST BE INCLUDED.

PAGE 1 - APPLICANT PROOF OF IDENTIFICATION

Please ensure ALL Dependent information is as it appears on your Dependent's Certificate of Indian Status A Dependent is a person, in which you have legal guardianship, who is under the age of 18 years old. If you need to include more names of dependents, please attach a separate page following the same listing guidelines as required on the Form

PAGE 2 - DIRECT DEPOSIT INFORMATION

Please attach a void cheque to your email, or alternatively you can bring "Page 2" to your financial institution and have the bank teller stamp and sign the "Direct Deposit Form."

PAGE 3 AND PAGE 4 - RELAEASE AND INDEMNIFICATION AGREEMENT

The last two pages require your signature as well as a witnesses' signature and full contact information. Your personal signature or whether you're signature as a Power of Attorney acknowledges and authorizes the Per Capita Distribution (PCD) to you, or to the individual you represent as you indicate on the Sheguiandah First Nation, RHT Per Capita Distribution Release and Indemnification Agreement for Minors, Power of Attorney or both.
